II. Updates from Professional Education Unit Head- Dean Murphy or Associate Dean Klemm

Following several bills from the Legislative sessions:

Senate Bill 77- allows the Chief Academic Officer to serve as a member of the EPSB. Asking that it can be a designee as well. May help the Board get quorum. Board must meet every 3 weeks.

House Bill 36- relates to misconduct in school and school sponsored activities.

Prohibits people signing NDAs that would be kept from the general public.

House Bill 48- encourages districts to offer an induction mentoring program instead of requiring it. Universities are not required to participate. The bill allows people to not offer induction training but makes it elective.

House Bill 170- Option 9 Alternative Teaching Certifications- we do not offer this at WKU because we have flexible programs. We do not need additional restrictions or qualifications to do what we do.

House Bill 205- this one is worrisome; removes the authority of the EPSB to require the successful completion of assessments prior to teacher certification.

House Bill 251- wants to require EPSB rather than CPE be the one that reviews teacher education programs every three years.

House Bill 263- Student Teacher Stipend Program- making sure we are clarifying what a KY resident is defined. The stiped only goes to student teachers who are teaching in the state of KY.

House Bill 272- defining dysgraphia. Called a cleanup bill; talks about some of the reporting requirements

House Bill 324- allows the local school board to require the minimum score requirements for certified positions for specific positions. Not EPSB setting cut scores but the local school board.

III.Accreditation & Continuous Improvement

Formative Feedback report looked good. Everything that was written up were things we already know and have addressed all of the items and submitted the addendum last Friday.

We are missing a few clinical documents and will reach out individually to get those before the site visit in April.
