Dropping the GRE altogether. <i>Friendly Amendment – Carl Dick shared the new language – The last bullet “For thesis track applicants, a WKU Biology graduate faculty member who has agreed to serve as advisor.” And add that language to the 2nd bullet like this “The statement must specify whether applicant is choosing the thesis or non-thesis (online) track, and thesis track applicants must identify a WKU biology graduate faculty member who has agreed to serve as advisor;”.</i> Vote: Approved</p>
