# SUSPENSION OF BACHELOR OF SCIENCE IN MOLECULAR BIOTECHNOLOGY

#### **REQUEST:**

Approval for suspension for the following academic program: **Bachelor of Science in Molecular Biotechnology**.

## **FACTS**:

The program faculty in the Department of Biological Sciences made the decision to close the B.S. program in Molecular Biotechnology because (1) enrollments have not grown as hoped when the program was created, and (2) the department has recently implemented curricular concentrations within the B.S. program in Biology (ref. #525). It is the intention to re-formulate the core of the Molecular Biotechnology program as a concentration within the B.S. in Biology. Beyond being more consistent and accessible for students, this will allow us to better market the concentration with the goal of increasing enrollments.

#### **BUDGETARY IMPLICATIONS:**

Closing this academic program to new admissions will have minimal impact on the University budget because the program will be re-formulated as a concentration within the B.S. in Biology.

## **RECOMMENDATION & IMPLEMENTATION DATE:**

President Timothy C. Caboni recommends approval of the suspension of the **Bachelor of Science in Molecular Biotechnology** to be implemented Fall 2026.
