Director of Honors College position has been advertised.

Wellness committee (chaired by Susan Howarth) is on campus – looking for additional representatives.

Gave D. Clark summer & winter enrollment data – he is looking at it.

3. SGA President, Sam Kurtz

Applications for WKU Bluegrass Leadership Scholarship for seniors in HS, closes in about a month. Goal is people in student council, president of club, captain of sports team, etc.

For most students: priority concerns are affordability, mental health, and campus safety, based on who SGA has talked to informally.

April 13th is SGA election, will kickoff election on South Lawn that Sunday evening with student performances.

Anticipates (maybe for the first time ever) SGA spending 100% of budget.

Pruitt: consider student performance events as an ongoing, monthly event instead of something like Shaq or Flo Rida. Campus Activities Board has the funds and oversees events, SGA working with CAB about possible collaboration and programming. \$5,000 just for police coverage if there is alcohol available.

I. Items for the benefit of the body

Jennifer Smith (WKU Legislative Liaison) and Molly Kerby visited to share legislation updates at the federal and state level. HB 4: have explained concerns to legislators and others that we have to protect academic freedom and accreditation. This appears to be without attack in the current iteration. Lack of understanding regarding accrediting bodies with legislators. Bill currently has a lot of exemptions (e.g., accreditation). Meeting tomorrow morning at 10:00am. HB 424 has passed the House, is in the Senate – have not heard any Senate discussions yet. HB 427 is about transfer pathways and is being monitored.
